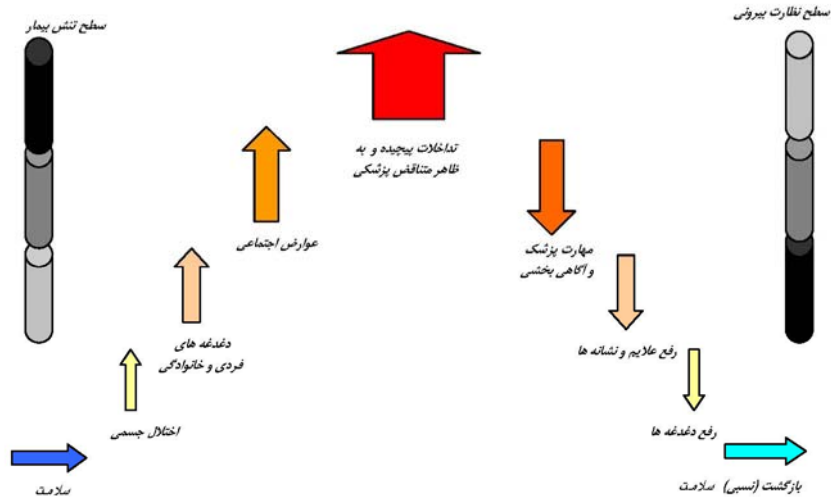

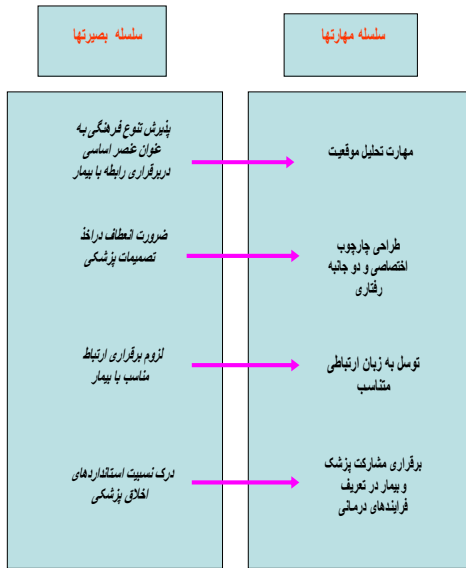
تصویر ۱. نمودار شدت تنش بیمار و مداخلات پزشکی

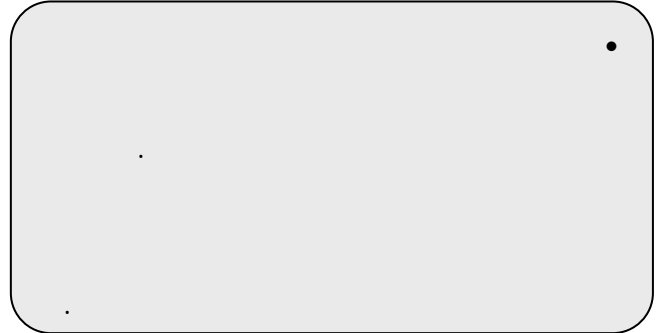
